# Minutes of the General Meeting February 3, 2010

The meeting was called to order at 7:00 p.m. by president, Rich Hardmeyer, there were fifteen members present.

**Minutes:** A motion was made (Green/Schenken) to forego the reading of the minutes of the last meeting and approve them as written. Motion passed.

**Treasurer's Report:** Marie Moore reported that we're in great shape financially. She also mentioned that long time member Jim Kirkwold had written the club a check for \$200.00 with a note saying, "Pay my dues for the year and put the rest in the pot." To acknowledge his generosity, Marie asked if it would be alright to send Jim a club hat and of course it was.

While on the subject of high finance, Jim Moore asked if the \$400.00 the National provides for the Dixon meet should be taken now or just deducted from our payment to the National when the meet is over. Using the "one in the hand is better than two in the bush" theory of accounting, it was decided that we'd take the money now.

Old Business: Regarding the Dixon meet Dave Kafton said all the food vendors are in place and Rich Ostrander is working on building the trophies and has almost completed the T-shirt design. Dave asked if there were any suggestions for speakers at the technical seminars. Ed Schenken said he had contacts at both Sierra Air Gas and American Stripping. This started a discussion regarding the pros and cons of having a commercial business conduct a seminar. While no one disputed the fact that welding supplies and metal stripping are something used by all it was also a concern that allowing a business to put on a seminar might turn the whole thing into a big sales pitch. It was finally agreed that having companies such as Sierra Air and American Stripping putting on demonstrations but not technical seminars would be a benefit to the meet and, to encourage their participation, if they were willing to join the AMCA we would give them a vendor space (or spaces) at no charge as long as no money changed hands. In other words they would be free to display their products, hand out brochures, business cards and other advertising materials but would not be allowed to actually sell anything.

The next item was the National Road Run. Rich Hardmeyer reported that the contract with the Biltmore Hotel is signed; in July he and Jim Moore will go up to Tahoe and layout the courses. They are going to wait until then to be sure there are no unexpected road closures due to ongoing highway repairs. Following a lengthy critique of the road run budget it was decided to set the registration fee at \$105.00 rather than original figure of \$100.00. Rich Ostrander said he will make up some trophies for the event.

Ed Schenken reported on his research regarding TV sets with DVD players which we could use at our club events and displays. After going over the various options it was decided that we would authorize Ed to purchase 26" TV monitor with built in DVD player for \$320.00 plus tax.

Jack Gormley reported that so far thirty-four people have signed up for the annual dinner he also asked if it would be all right to invite Tom Motter to the dinner to promote and, possibly speak about, his book, *Sacramento, Dirt Capital of the West*, which gives the history of all the famous race tracks from the old State Fair grounds to Hughes Stadium. The club felt there would be no problem as long as he didn't actually sell any books that evening. Marie Moore asked for \$200.00 for raffle prizes for the dinner. A motion was made (Green/Kinney) to provide Marie with that amount. Motion passed.

**New Business:** Bob Pratt gave a run down on "Motorcycle Awareness Day" to be held May 16 at Sierra College in Rocklin. Bob would like us to bring out some bikes for a display and, perhaps, hold and impromptu show with some sort of people's choice award being given.

Finally, Marie Moore held the raffle for three free dinners at the annual banquet. The winners were Rich Ostrander, Ed Schenken, and Dave Kafton.

Meeting adjourned at 8:19 p.m.
