Fort Sutter Meeting Minutes December 2, 2023

- Call to Order: The December 2, 2023, meeting was called to order at: 1:08 pm by Bob Henry, Fort Sutter President
- Welcome New Members at the meeting: None at the meeting. Guests: Kathleen Allen (Mike Laird's wife)
- **Membership**: Julie Loewen reporting for Karie Schenken stated there are: **94** Primary members, **32** Associates, **3** Junior members, and **11** Honorary members for a **total of 144**.
- **Treasury Report**: Julie Loewen reports the treasury, has as of 11/30/2023 total assets of \$31,967.98.
- Minutes: A motion was made by Tracy Stahlman and seconded by Mark Loewen to: Approve the minutes as written for the October 7, 2023, meeting. The motion was unanimously approved.

Old Business

- **Prior Club Rides:** John M. led a ride after the October 7th meeting to Locke (Hwy 160 along the Delta) to lunch and return.
- **Membership:** Karie S. reports Dan Post from Carson City has joined Fort Sutter. He is retired and owns 5 antique motorcycle. Welcome Dan to Fort Sutter.
- NORCAL Cycle Swap: Fort Sutter attended the November 12th Cycle Swap. John M. reports that the NORCAL Cycle Swap continues to be a venue to help recruit new members. At the most recent Cycle Swap, there were 2 NEW National memberships and 1 NEW Fort Sutter member, Chris Avila, to Fort Sutter. Members, who most recently attended were, Mike Williams, Tracy Stahlman, Joe Giammona, John Markley and Bob Henry. In addition, other Fort Sutter members stopped by which helped show that Fort Sutter was there in force. If you haven't volunteered to staff the booth, contact Bob H. or Tracy S. for more details.

New Business

- **AMCA National Update:** John Markley, 2024 AMCA President elect, thanked everyone for their support during his years on the Fort Sutter Board of Directors as the Club Secretary and Newsletter Editor. Both John and Phyllis will remain active members in the Club.
- December Ride: Fort Sutter members will meet and ride to Nevada City to participate in the Nevada County Toy Run on Saturday December 9th. Two meet-up locations 1.) 8:00 am at Mel's Diner 3000 J St. Sacramento.
 2.) 9:00 am at McDonald's 4211 College Blvd., Rocklin. Refer to flyer for more details. Members were asked to bring one or more UNWRAPPED toys to today's club meeting if not riding. Tracy S. will deliver to the Fairgrounds in Grass Valley. Important: Fort Sutter is a Silver Sponsor with a \$300 donation. Over 1,000 riders, on average, make the Toy Run – Rain or Shine. Who is going?
- **Club Banquet: Saturday, February 10th, 2024: Tracey Kleber update:** Tracy distributed the Banquet Flyers to all members at the December meeting. Additional flyers will be available in the Newsletter and Tracy encouraged everyone to attend. The idea of providing raffle prizes at the banquet was discussed and it was determined that a 50/50 promotion would benefit both the Club and winner. A motion was made by Mark Wiebens and seconded by Margie Siegal to: **Offer a 50/50 drawing at the 2024 Club Banquet.** The motion was unanimously approved. Note: Bob H. announced he received 5 one-year renewals to award Club members either at a meeting or Banquet/picnic.
- Fort Sutter National Meet in Dixon. Bob Henry, President, reviewed the National Magazine advertisement for the June 14-15, 2024, National Meet in Dixon. The advertisement is smaller and will be easily seen by members as they read the National Magazine. The free ad will be included in the March/April 2024 issue.

- Upcoming Events: NORCAL Cycle Swap: December 10, 2023. Tracy Stahlman stated he will not be able to attend the Cycle Swap meet due to leading the December 9, 2023, the ride to attend the Nevada County Toy Run, however, the booth is available for others to use at the Swap. Contact Tracy if interested.
- Fort Sutter purchase of enclosed utility Trailer: Tracy Stahlman recently discovered a used utility trailer for sale and discussed the need for it's purchase. With rental costs for the storage unit in Dixon increasing, and its distance away from Sacramento, it was determined that a purchase would be worthwhile. The trailer is a Charmac with dimensions of 8.5 x 16' with cabinets and a ramp. After review and discussion of a purchase, a motion was made by Stan Smith and seconded by Rich Ostrander to: Purchase an enclosed trailer suitable for use by Fort Sutter with a price of no more than \$12,000 including all fees to register . The motion was unanimously approved.
- Fort Sutter Club Hats: Danny Marquis recently met with a company in Placerville that can produce Club hats (red) in two styles. He stated they will be embroidered with Fort Sutter on the front and possibly the AMCA logo on the back. The price per hat is approximately \$20.00. He has ordered two hats for himself and will bring both to the February 2024 meeting.
- Club Merchandise: Tracy Stahlman said that it is time to begin ordering merchandise for the Club, to include T-shirts, meet pins, and other items offered for sale at Dixon. Kim Stahlman said she prefers not to design the logos, or other items to be on the merchandise but let others handle this task. Tracy showed logo designs from the past to reflect Fort Sutter logos back in the day. Members were receptive and encouraging for this idea. A motion was made by Bob Henry and seconded by Mark Milton to: Have Tracy Stahlman continue designing past logo designs and begin the ordering of merchandise. The motion was unanimously approved.
- Fort Sutter Club Board of Director Elections: Nominations began, and the following board members were nominated to fill <u>four</u> board of director positions: Joe Giammona, Julie Loewen, Tom Myers, Jim Schenken and Tracy Stahlman. Voting then took place and the following board members were voted in to serve the 2024-2025 term: *Julie Loewen, Tom Myers, Jim Schenken and Tracy Stahlman*. However, Jim Schenken announced he would not serve for this term and *Joe Giammona* was then selected to serve the 2024-2025 term as the fourth Board member. Next, a short break took place, and current 2023 Fort Sutter Board members left the room to nominate and vote for three officer positions that are ending on 12/31/2023. They are the Vice President, Secretary and Treasurer positions. After nominations and voting, the following board members will serve as officers for the 2024-2025 term: Tracy Stahlman, Vice President, Julie Loewen, Treasurer, and Tom Myers, Secretary. Congratulations go out to all current and new board members. As we say goodbye to John Markley, we thank him for his years of service, both on the Board as Secretary, and as our Newsletter Editor. As we begin 2024, Tom Myers will assume these duties.




